1.2 Donation Button on the website

Using the donation button provided through DonorBox platform. The following personal information are collected:

- First Name
- Last Name
- Email
- Company Name (optional)

These data can be used by Sunshine in Nosy Komba Foundation to respond to your questions and claims.

These data are stored on DonorBox Platform account of Sunshine in Nosy Komba Foundation.

A request can be sent to DonorBox under user request to get them or delete them.

1.3 Email

Answering email asking for receipt for tax deduction by the donor, the following information are collected (beside already collected in 1.2):

- Residence address
- Tax ID

These data are used by Sunshine in Nosy Komba Foundation to provide receipts for tax deduction to the specific donors.

Data receipts are stored on Google Drive of Sunshine in Nosy Komba Foundation.

Donors can always contact Sunshine in Nosy Komba to get these data or to ask to delete them.
