Privacy Policy

Sunshine in Nosy Komba Foundation is a non profit public interest organisation based in the Netherlands since 2017.

Your privacy and personal data is important to us. Therefore, we are committed to letting you know what data we collect, why we collect it, and what we do with it. If you have any questions about how we use your personal information or comply with data protection legislation, please email us.

1.0 Personal information collected (how and why we collect Personal information)

1.1 Contact Form on the Website and Email Communications

By using the contact form available in Contact Us page of this website through Wix contact form and/or by sending us an email, you provide the following personal information:

- First Name
- Last Name
- Email Address
- Questions and/or Claims
- Communication

This data can be used by Sunshine in Nosy Komba Foundation to respond to your questions, claims and/or communicate with you.

These data are stored on Wix of Sunshine in Nosy Komba Foundation, Gmail accounts and Google Drive.



1.2 Donation

By using the donation button provided through DonorBox platform and/or transfer your donation directly to our bank account, you provide the following personal information

- First Name
- Last Name
- Email
- Company Name (optional)
- Bank account information
- Amount donated
- Optional Message

This data can be used by Sunshine in Nosy Komba Foundation to respond to your questions and/or claims.

This data may be processed by payment providers, such as Paypal and Stripe, and stored on the DonorBox Platform account of Sunshine in Nosy Komba Foundation and in the transactions history of our bank account of the ABN AMRO.

1.3 Receipt via Email

By requesting a receipt as a donor or a regular sponsor, you provide the following information, (beside already collected in 1.2):

- Residence address
- Tax ID

This data is used by Sunshine in Nosy Komba Foundation to provide receipts for tax deduction to the specific donors.

Data receipts are stored on Gmail and Google Drive of Sunshine in Nosy Komba Foundation with limited access rights.

1.4 Events and Workshops Online

By attending an event or workshop online your image or voice may be captured in the video camera, but only and if you turn it on. Note that Sunshine in Nosy will not record your image in events or workshops to protect your privacy.



This data is used by Sunshine in Nosy Komba Foundation to perform the events and allow your participation.

Note that to hold our online events may use Video Conferencing System, such as Zoom, and social media networks, such as Facebook Live.

2.0 Data controller

The data controller is Sunshine in Nosy Komba Foundation, a non profit organization based in the Netherlands (registration (KvK) number 67989675) at Smidssteeg 1, 2312 BP, Leiden, The Netherlands.

3.0 Our third-party data processors

We use a number of third-party service providers who process personal data on our behalf. These third parties have been carefully chosen to comply with our legislation.

The majority of these third parties and sub-processors are based in the United States and they have entered into EC Standard Contractual Clauses to transfer personal data to third countries that do not have an adequate level of data protection.

4.0 Legal Basis

Your personal data will be mainly used for the purposes of complying with our legal obligation, when we have a legitimate interest to do so and/or when you have requested and provided your consent.

5.0 Data Deletion

Sunshine in Nosy Komba Foundation holds your personal information for the necessary period of time to fulfil the purposes described in this Privacy Policy, in particular:

- After a period of 2 years without you contacting us or receiving payments from you, we will delete our communications and inactive accounts to ensure your right to data deletion;
- Every 2 years, we will also delete your transaction and financial information as it is no longer needed.

6.0 Your Rights

Subject to particular situation, you may have the right to:

- Request access a copy of your personal information;
- Request to receive your personal information in a structured, commonly used and machine-readable format;
- Have your personal information amended if it is inaccurate or incomplete;
- Ask for sending your data to someone else;
- Request to have your personal information erased;
- Restrict or object to our processing of your personal information;
- Withdraw your consent at any time, if you have consented to our use of personal information;



- Lodge a complaint to the national supervisory authority, if you are not satisfied with the way we treat your personal information.

7.0 Changes to our privacy policy

This privacy policy may change from time to time in line with legislation or industry developments. This Privacy Policy and any changes to it shall be approved by the Board of Directors of the Foundation.
